New Mobile Video Conference Service

CCL is pleased to offer a new mobile Commercial Grade Video Conference (VC) Service. This service is available for use by all Shareholders and tenants in Wentworth, Selborne, Lockhart and Windeyer Chambers.

The VC equipment will be delivered on a trolley to chambers (as displayed in the image below), setup and support is offered during business hours for the duration of the VC. The cost to use this service is \$200 (ex GST) per day (Shareholders will be provided with a 10% discount).

The VC system is Logitech Meetup using a 43" screen and is compatible for conferences, seminars, CPD's, meetings and hearings and we have successfully hosted webinars directly from this equipment. The equipment supports the following platforms:

- Cisco Webex
- Microsoft Teams
- Zoom
- Blue Jeans
- SIP (via Webex Teams)

Members can either bring their own laptop and connect to the equipment via USB/HDMI (CCL Network Staff will provide support for the set up), or the VC can be provided as a fully integrated service without any requirement for Members to supply their own equipment.

Bookings to use this mobile service are essential and must be made a minimum of 24 hours prior to the conference/seminar/hearing/meeting, payment in advance of the booking is required.
