MAINTENANCE CONTRACTORS AND SERVICE PROVIDERS carrying out;

- photocopier repairs;
- information and technology services;
- water filter and boiler services;
- indoor plant hire services and caterers for functions;
- minor furniture repairs, furniture removals, furniture deliveries; and,
- minor appliance repairs and major appliance deliveries;

<u>are not required</u> to produce documentation for each visit, however they must sign in on Level 1 and can pre-register with CCL beforehand. Contact CCL for pre-registration at **(02) 9231 3644** or at **maint@ccl.com.au.**

WORK IN CHAMBERS such as the following examples (with references to clauses of the Fit Out Guide noted);

- carpet, vinyl or soft flooring installations (clause 5.5);
- blind, screen or shutter installations (clauses 5.5, 5.28 & 5.36);
- picture hanging (clause 5.5);
- painting (clauses 5.5 & 5.34); and,
- floor polishing (clauses 5.5 & 5.34);

will require CCL to be notified no less than 48 hours in advance and must observe the following basic requirements:

- 1. Complete and sign the application pages of the Fit Out Guide and return this to CCL.
- 2. Provide CCL with the necessary insurance certificates.
- 3. Provide credit card details for the pre-authorisation of the \$1,800 security deposit.

MORE SUBSTANTIAL WORK IN CHAMBERS must have plans and a written scope submitted no less than 28 days prior to the anticipated commencement date, for a detailed review and approval process.

FLOOR RENOVATIONS will require detailed consultation with CCL no less than 6 months prior to commencing work on site and approval from the Board of Directors.

IMPORTANT REMINDERS:

- o You must sign on and off every day at CCL's offices (open 24 hours).
- o You will lose your security deposit of \$1,800 if you;
 - breach the site rules, set off the security alarm or chock doors open;
 - set off the fire alarm or smoke on site;
 - leave a mess behind, leave tools or equipment in common areas unattended; or,
 - cause damage to the lifts or common property.
- o Between 8am 6pm Monday to Friday, the following are not permitted (Section 3.3):
 - Noisy work.
 - Major deliveries to site or removal of rubbish from site.
 - Disruptions to building services.
 - Generating dust, odours or noxious fumes.
- o You will have to make your own arrangements for access.
- Remove and reinstate the carpet from the lifts and request lift curtain protection if necessary.
- Don't tamper with, drill into or affix anything to the window glazing or window frames.
